Proposed Ordinance 277 (Bill No. 1-2024) has been posted for 5 days for public view, "AN ORDINANCE ADOPTING AND ENACTING A NEW CODE OF ORDINANCES OF THE CITY OF WAYLAND, COUNTY OF CLARK, STATE OF MISSOURI; ESTABLISHING THE SAME; PROVIDING FOR THE REPEAL OF CERTAIN ORDINANCES NOT INCLUDED THEREIN, EXCEPT AS HEREIN EXPRESSLY PROVIDED; PROVIDING FOR THE MANNER OF AMENDING SUCH CODE OF ORDINANCES; PROVIDING PENALTY FOR THE VIOLATION THEREOF; AND PROVIDING WHEN THIS ORDINANCE SHALL BECOME EFFECTIVE" was read by title only for the first time. Proposed Ordinance 277 (Bill No. 1-2024) was read by title only for the second time. Sherry Bunker made motion 2nd by Joe Booth to accept. Vote was taken by roll call - Sherry Bunker-aye, Joe Booth-aye, Donna Ash-aye, Connie Handyside-aye.

Proposed Ordinance 277 (Bill No. 1-2024) passed.

Her concern was the attracting of rats and bugs do to the piling of garbage on the properties of Anthony Fox and Joe & Laurie Machmer which are her neighbors.
